

Guidelines for Submission of Manuscript to Mineral Processing Transactions (MPT)

Scope of Journal

Mineral Processing Transactions is a biannually published international journal of IIME Bhubaneswar Chapter in the mineral processing and its allied fields. The brief but not limited aim of the journal is to publish articles in the areas of mineral characterization, mineral enrichment, recycling and reuse of mineral bearing wastes, modelling, optimization pilot scale studies, plant automation, slurry transportation, agglomerations, plant audit and case studies. The journal publishes following categories of articles

- a) Original article
- b) Invited articles
- c) Review articles
- d) Short notes (including short discussions on the emerging technologies or case studies on the innovations made in the industries)
- e) Letter to editor (including discussions on the policies related to the mineral processing and its allied industries)

Authors are responsible for obtaining permissions for copyrighted material. Authors are also responsible for avoiding plagiarism of any form. The “Mineral Processing Transactions” have zero tolerance towards plagiarism. Authors have to submit copyright transfer form once the article is accepted for publication.

Structure of article or manuscript

The manuscript should be structured as follows

- a) Title Page:
- b) Abstract
- c) Main body of manuscript
- d) References
- e) Annexures

The article or manuscript should be written in English language in MS word. Times New Roman or Arial font should be used with font size of 12. Original, invited and review articles should contain maximum 5000 words. Short notes and letter to editor should be restricted to 1000 words

a) Title Page:

Title page will contain the following

- Title of article
- Name of Authors along with their affiliations
- Name of Correspondence author along with communication information (i.e. address, email, etc.)

The title of the article or manuscript should be brief and should not contain any equation of formulae

Name of all the authors having contribution to the article should mentioned along with their affiliations. The affiliations need to be indicated by a superscript at right hand side of name and the address of affiliation should be written below the name.

Name of the corresponding author has to be clearly mentioned for all correspondence on behalf of all the authors.

b) Abstract:

This section is only applicable for Original, invited and review articles. The abstract section should give concise summery of the work presented in the manuscript or article. At the end of the abstract five (05) keywords to be given.

c) Main body of the manuscript:

The main body of the manuscript may be written with different sections such as introduction, experimental, material methods, results, discussions, conclusions etc. All sections and subsections have to be numbered sequentially i.e. 1., 1.1, 1.1.1, 1.2, 1.2.1, 1.2.2., 2. 2.1, 2.2 etc.

All formulas or equations in the text should be numbered chronologically

All tables in the text should be chronologically numbered i.e. Table 1.....Table 2etc.

All tables should have a caption placed at the top of the table. All tables should be given after reference section and to be kept chronologically

All figures in the text should be chronologically numbered i.e. Figure 1.....Figure 2etc.

All figures should have a caption placed at the bottom of the figure. All figures should be given after table section and to be kept chronologically

At the end an “*Acknowledgement*” section will be their where in the sponsor of the work has to be clearly acknowledged.

d) References:

References that are mentioned in the main text should be present in the reference list. All references in the text should be mentioned in the manuscript as numbers inside a bracket

Ex. [1] or [1 and 2] or [1 - 7] or [1 - 3 and [6 - 8] etc.

The style of mentioning the references in the list are as follows

For journal articles

[1] Names, title of article, journal name, year of publication, vol. no., issue no., page no.

Ex. X. XYZ, Y. ZXY, and Z. YXZ, title of the manuscript, Mineral Processing Transactions, 2022, Vol. 1, 1, 5-10.

For conferences proceedings

[1] Names, title of article, Conference Name, Editor Name, year, Published by, page no.

Ex. X. XYZ, Y. ZXY, and Z. YXZ, title of the manuscript, Conferencce-2022, X. XYZ, 2022, IIME Bhubaneswar Chapter, 5-10.

For book chapter

[1] Names, title of chapter, Title of book, Editor(s) Name, year, Published by, page no.

Ex. X. XYZ, Y. ZXY, and Z. YXZ, title of the chapter, BOOK, X. XYZ, 2022, IIME Bhubaneswar Chapter, 5-10.

For book

[1] Editor(s) Names, Title of book, year, Published by, page no.

Ex. X. XYZ, Y. ZXY, and Z. YXZ, BOOK, X. XYZ, 2022, IIME Bhubaneswar Chapter, 5-10.

Article from internet source

[1] URL of the article, DOI.
